2. If the flight or seat is not available on the above dates and sector you can quote earlier for earlier date and later for later date.
3. The purchaser reserves the right to **reject a bid or all the bids** if it is **found non-feasible** or if we lack the capacity to bear the cost resulting from your early or late quoted dates.
4. The rate should be quoted as per the sector given above and will be selected for the **most economical and direct route**. Evaluation will be done sector wise based on the most economical and direct route.
5. Airline and seats must be confirmed while submitting the bids and **submit confirmed itineraries details.**
